Case study based teaching and learning, videos, PPT, Interactive live sessions, and Discussion on current practices and Feedback are some of the ways through which classes have become interesting from the students' perspective and response The grading and evaluation along with granting attendance which will eventually accumulate into the DSE credits have been designed, planned and executed on completion of each Unit.

Overall objective of these programs in this context is to fall in line with the goal, vision and mission of the department and University, empower, and encourage students to become complete finance professionals in the field of Risk Management and Insurance thereby enabling and enhancing their prospects of a better career as employees and Entrepreneurs.
