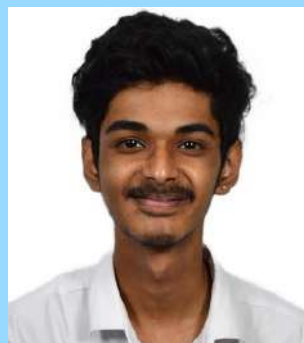

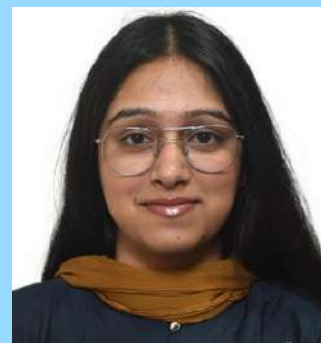

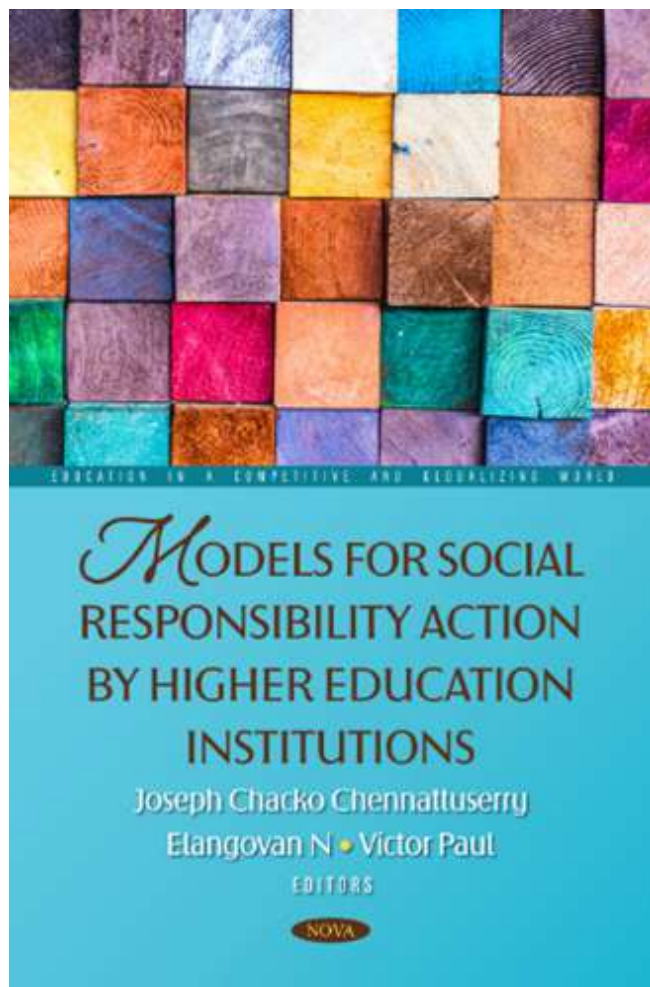
Insights from our publication - 'Models for Social Responsibility Action by Higher Education Institutions'

DPS at the Forefront of ‘Suraksha Chakra’: A Pioneering Insurance project in Puthuppadi Gram Panchayat”

As part of the University’s nationwide insurance project - ‘Suraksha Chakra’, students and staff from the Department of Professional Studies (DPS) under the leadership of Dr Biju Toms, Director, CUSCFA have undertaken a survey on the extent of insurance awareness and coverage in Puthuppadi Gram Panchayat of Kozhikode district in Kerala. This initiative has been taken by CHRIST (Deemed to be University) after the successful completion of the ‘100% Insurance Coverage of the Chakkittapara Panchayat’ project which was also covered by Asianet News channel. Chakkittapara became the first Village Panchayat of Kerala to be completely insured; and our Department, on behalf of the University, is striving to make the Puthuppadi Village Panchayat, Kozhikode the next completely insured village.

The Co-operative bank of the Puthuppadi Village Panchayat has collaborated with CHRIST (Deemed to be University) for this project. The transformative insurance survey and awareness programme was inaugurated by the Thiruvambadi MLA, Mr Linto Joseph. As the initial step, volunteers from CHRIST (Deemed to be University) and students from LISSAH College, Kerala are conducting a survey in the village. The survey covers various aspects, including the understanding of insurance products, the current level of coverage, and the barriers preventing residents from accessing insurance services. The collected data will be analyzed to formulate informed strategies that address the specific needs of Puthuppadi Gram Panchayat. The team plans to add families which are not part of any Insurance Policy, to the ‘Pradhan Mantri Suraksha Bima Yojana’ scheme, launched by the

Central Government of India. This scheme provides an insurance coverage of ₹2,00,000 in case of an accidental death and ₹1,00,000 in case of any disability arising from an accident. The Co-operative bank plans on ensuring insurance coverage to every resident of Puthuppadi. Mr. K C Velayudhan, President of the Puthuppadi Co-operative Bank, stated that the bank is primarily gathering information on individuals without land or property, and those with disabilities or illnesses, to optimize utilization of the insurance scheme.

Despite its leading status in health and education, Kerala exhibits a notable lack of awareness regarding insurance. Thus, the primary goal of the 'Suraksha Chakra' project is to raise awareness about insurance schemes in the remote regions of the state. Project head, Dr Biju Toms, stated that even the minimal coverage provided by these insurance schemes significantly affects those residing below the poverty line.
