


Guest Lecture on 'Building Conventional Businesses' by CA Prateek Gupta

She won't last long.







Student Address on Project Aajeevika – United Nations SDG Youth Summit 2022

Project Aajeevika was started by Adarsh Kunnath Menon (2112244) and his friend Dishita Swaika in March 2020 to address the 8th UN Sustainable Development Goal, 'Decent Work and Economic Growth'. They are part of a program run by the organization '1 Million for 1 Billion' (1M1B), a leadership, entrepreneurship, and jobs creation initiative aligned to the United Nations Sustainable Development Goals (SDG). It has a special consultative status to the UN Economic and Social Council (ECOSOC) and is associated with the United Nations Department of Global Communications. They nurture the world's most promising youth leaders by helping them find their passion and purpose through a framework and convert them into actionable projects aligned with the UNSDGs. The program consisted of 3 levels of intense mentoring. Adarsh and Dishita were selected as one of the top participants from over 120 students who participated in the 1M1B Future Leaders Program across India.

Some notable people the participants were able to interact with during the course of the event were Mr. Erik Solheim, former minister of Climate and Environment of Norway and Director of UN Environment, Ms. Karuna Singh, the Regional Director of Earth Day Network, one of the world's largest environmental movements, Ms. Debjani Ghosh, President of NASSCOM, Ms. Charu Pragma, an advocate of the Supreme Court of India and social activist, Ms. Poonam Kaur, Indian actress and handloom promoter, Ms. Shweta Rajpal Kohli, Director and Head of Public Policy, Sequoia Capital India, Ralph Guggenheim, Co-founder and VP of Pixar Animations, Ms. Hawa Diallo, Chief of the Civil Society Unit at the United Nations, among others.



They initially aimed to provide sustainable employment opportunities to the urban population of lower-income households. They chose this problem as they saw the massive scale of unemployment around them and the realisation that once people had access to jobs, they could mitigate other issues they faced, including access to necessities. However, they realised it would be tough to proceed with the project because of COVID-19 and the massive scale of unemployment. Thus, they pivoted their project multiple times. While speaking to the latter,

They found that the families struggled to keep things together during COVID-19 without permanent jobs and ongoing salary deductions. This is where the idea of a fundraiser germinated. The duo raised almost Rs.2,70,000, approximately \$3570 and helped 250 families with essentials, including ration and sanitation items. They partnered with Oxfam India to distribute around 50 kits, the rest independently. They started off by identifying potential target audiences and interviewing several parties ranging from NGOs to people belonging to lower-income families. As for their main aim, which was to provide sustainable job opportunities, they partnered with Unnati Foundation and helped

fund a 165+ hours (30 Days) job skills training program for over 20 final-year students in government colleges. Some skills the students learnt include workplace etiquette, confidence building, spoken English, hygiene, life skills, etc. They also partnered with Nudge Foundation and helped fund an asset for rural women entrepreneurs, which they used to kickstart their Future Perfect program, involving entrepreneurial ventures. They wish to build the sustainability of their project and continue on their mission to help lower-income families achieve decent work to see some economic growth.


